POLICIES/TERMS

- 1. All pets must enter clean, free of fleas and parasites, with skin and coat in good condition. Since we strive to keep a clean environment a grooming charge may apply if we feel your pet requires such services.
- 2. All pets being boarded or groomed must be current on vaccinations and proof of vaccinations required. Bordetella must be given within the last 6 months prior to boarding. Proof of current Rabies and DHLPP vaccination also required.
- 3. Dogs must be in good health and not have been ill with any communicable diseases within the last 30 days.
- 4. Medication must come dispensed in original containers with clear instructions
- 5. Pets food must come in zip-locked bags, pre-portioned for EACH meal. We apologize but we do not have space for large bags of food. We can provide your pet with our HOUSE food, but there is an additional charge.
- 6. We provide blankets for each dog's comfort, however you may bring their own bedding from home, as long as it is machine washable and can fit in our washers.
- 7. When you sign the Guest Registration form you are consenting to emergency medical care in the event your pet(s) become seriously ill. We will make every attempt to contact you at the phone numbers you provide us. We will contact your vet first, our on call vet, then emergency if needed.
- 8. The Animal Den Pet Resort & Spa is not responsible for the loss of toys, bedding, or blankets that are not clearly labeled with the pet's name.
- 9. Check out time is 12:00 pm. If your pet is not picked up by check out, day care charges will be added to your bill.
- 10. Resort hours are posted for your convenience. Before/After hour pick up can be arranged for a charge.
- 11. Because we have limited space and a waiting list, a 48 hour cancellation and a 72 hour cancellation on holidays is required on your reservations. Any reservation not cancelled per our policy will be billed to the guest.
- 12. Your dog will be evaluated for group play sessions. We reserve the right to refuse group play time for any pet that possess a threat to a staff member or other boarder. Please inform us if you chose to not have your pet participate in group play sessions.
- 13. Fees for boarding/grooming and other services are due and payable when your pet is released. We do not allow partial payment or billing. The pet will only be released to the owner unless arrangements have been made in advance. If your pet is left longer then 30days without payment, you voluntarily relinquish rights of ownership.
- 14. Our doors are locked and not open to the public on: Easter, Thanksgiving, Christmas, New Years Day, July 4th, Memorial Day, and Labor Day. If your pet is here during one of the above holidays, an extra day's stay is added to your bill.
- 15. Owner agrees that The Animal Den Pet Resort & Spa shall not be liable for any loss or damage to the animal by any cause whatsoever, including fire, theft, and escape of animal. Owner assumes and understands that the pet is in an environment where other pets can be located together in a social atmosphere and the facility is not liable for the damaged caused by or from another animal.
- 16. The Animal Den Pet Resort & Spa will not knowingly accept dogs into our play sessions that have not been spayed/neutered.
